In exercise of powers conferred under Section 16 and 17 of the Atomic Energy Act, 1962 as applicable, read in conjunction with Rule (3) of the Atomic Energy (Radiation Protection) Rules {AE(RP)R}, 2004, the Atomic Energy Regulatory Board (AERB) hereby issues the Licence in favour of Mr. CHUNILAL BHANJI GHERWADA, CEO, INSPECTION TECHNOLOGY, Mumbai to possess and operate the Industrial Radiography Exposure Device (s) (IRED) containing radiography source / radiation generating equipment for industrial radiography purposes at authorised site(s).

 - Guide on Security of Radioactive Sources in Radiation Facilities no. AERB/RF RS/SG-1, 2011 and Security of Radioactive Material (RAM) during transport No. AERB/NRF-TS/SG-10, 2008
 - Other applicable regulatory documents issued by AERB;
- Ensuring compliance with the terms and conditions cited above and stated in Annex-1.

This Licence may be suspended, modified or withdrawn as deemed fit in the event of contravention of the provisions of the above Act / Rules / Codes or terms and conditions.
